Motion [M Pohlmann] to Accept the 2024 Budget & 2023 Financial Statement; Second [Dave Seamen]; Discussion: None; Passed; it is noted that Mary Pohlmann reviewed the 2023 financial records monthly & the 2023 annual report on February 24, 2024, as required by Item 23 of the Ozark Financial Operating Guidelines.
